5. No patient detail is to be used for any other purpose other than academic purposes restricted to the College alone.
6. The college should ensure compliance to the respective regulatory bodies in terms of accreditation and other norms as required in addition to this the arrangement under this MOU is limited to and shall be in terms of procedure list attached herewith as **Annexure- A**.
7. The College will provide its Faculty onsite to effectively implement and supervise the clinical rotation during all hours.
8. The College faculty will be responsible for planning, directing and evaluating the students learning experience.
9. The College will provide Alexis Hospital with a list of the students who are participating in the clinical experience program, the unit locations within the hospital where they are assigned.
10. The Hospital will provide physical orientation to the college faculty in lieu of providing an understanding of the physical set up of the hospital.
11. The College will inform its faculty and students of the hospital's policies and regulations, which relate to the clinical experience program at the hospital.
12. The students will have to abide by the code of conduct.
13. The hospital assumes no responsibility for the cost of meals, uniforms, transportation, parking or health care etc., of College faculty and students who are participating in the clinical Experience program.
